CCE Holding (CCE) plans, builds, finances, and manages alternative investments in the high-growth global sector of photovoltaics with the aim of playing a key role on the global energy transition towards low carbon technologies. CCE's mission is to be the solution partner for the future of energy supply contributing to the achievement of the UN Sustainable Development Goals and the ambitions put forward in the Paris Agreement.

CCE will be a fully integrated independent power producer (IPP) active in the fields of project development, construction, financing, and management of renewable energy assets. At CCE, we pursue a solution-oriented approach that reflects our values and ambitions along the entire value chain – from development, planning and financing, right up to the construction and operation of photovoltaic systems.

CCE is committed to operating its activities in a sustainable manner, taking long-term environmental, social and governance consequences into consideration in our activities.

We adhere to relevant laws and regulations in all the markets in which we perform our activities. Additionally, we use reasonable commercial efforts, having regard for the size and context of our operations, to align our activities with established and recognized international guidelines and recommendations, in particular:

- ILO Declaration on Fundamental Principles and Rights at work
- OECD-Guidelines for Multinational Enterprises
- UN Guiding Principles on Business and Human Rights

CCE is committed to comply with legal or similar other requirements in the respective countries and to be fully transparent in this regard as a minimum standard, although we always will seek to exceed the standard.

We value transparency and provide relevant ESG reporting to investors and other stakeholders.

#### Scope

This Code applies to CCE and all its operating Groups, Divisions, joint ventures, and other operations globally (collectively, "CCE"). This policy also applies to all persons who act on CCE's behalf, including employees, officers, directors, consultants, agents, and contractors.
